The software and related documentation that you are about to access (the “Software”) is offered by AI Medical AG, having its principal place of business at Goldhaldenstrasse 22a, 8702 Zollikon, Switzerland, for your use in accordance with the agreement below.

By clicking on the “SUBMIT” (or similar) button during the download, installation or using this Software, you represent that you have read, understood and agree to be bound by the terms and conditions on this User Agreement (“Agreement”). You declare you have the legal capacity to enter into such agreement, and you consent to be bound by all the terms and conditions set forth below. If you do not accept these terms and conditions then you are not granted a license and are not authorized to access, download, install or use the Software. The Software is available only to individuals who are at least 18 years old.

1 Parties

“User” or “you” means the individual who or entity that accepted and agreed to be bound by the terms and conditions of this License.

“AI Medical” or “we” means AI Medical AG, having its principal place of business at Goldhaldenstrasse 22a, 8702 Zollikon, Switzerland, registered in the Commercial Register maintained by the Federal Registry of Commerce (FRC), Switzerland (UID CHE-416.568.892).

2 Definitions

“Agreement” means this User Agreement covering use of the Product by individual users.

“Software Version” means a release, update, or upgrade of a particular Software that is not identified by AI Medical as being made for the purpose of fixing software bugs.

“Personal Data” means any information relating to an identified or identifiable natural person.

3 Right and Title of the Software

Except to the extent otherwise is provided under any open-source licenses, as referred to under section 4 below, the following applies.
